From 377 acres of farmland in 2012, Yggdrasil grew to 594.45 acres in 2013. This includes three parcels in New Hampshire that are now leased to the farmers of Educational Community Farm in Wilton, New Hampshire and two new parcels near East Troy, Wisconsin including additional grazing lands and hayfields that will need some stewarding. One of properties in Wisconsin also includes a residence that Yggdrasil investing in fixing up in order to lease for some income. In addition to the land acquired, Yggdrasil worked very closely with the Russell Family Foundation in New Hampshire to apply for and receive matching funding to purchase (to close in 2014) a conservation easement on land adjacent to YLF's other
