We acquired an additional 300 acres of land in the East Troy, WI area, for a total of approximately 800 acres just in WI. This includes several parcels along with stewardship gifts that support YLF restoring the agricultural land that had not been managed well. It is also looking into working with the Dairy Grazers Association Apprenticeship program to have young dairy farmers train on and manage the land. This would also further YLF's mission of supporting the vocation of farming. YLF also worked to purchase a conservation easement in NH but due to delays in program review and the number of players involved the project will more likely close in early 2015. This would add an additional 200 acres under YLF protection.
