SIGNIFICANT RENOVATIONS WERE COMPLETED ON AN HISTORIC FARMHOUSE IN WISCONSIN, AND YGGDRASIL WAS ABLE TO OFFER HOUSING TO THE FARMER WHO LEASES ABUTTING LANDS AND GREENHOUSES. THE FARMER AND HER FAMILY ARE NOW ABLE TO RESIDE ON THE LAND SHE IS FARMING. FUNDS WERE ALSO EXPENDED TO UPGRADE AND REPAIR A MILKING PARLOR TO PROVIDE A LONG-TERM LEASE TO ENTHUSIASTIC YOUNG DAIRY FARMERS.
